

Privacy Policy

Dan's PT ("we", "our", "us") respects your privacy and is committed to protecting your personal information in accordance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs). This Privacy Policy explains how we collect, use, store and protect your personal information.

1. What personal information we collect

We may collect the following types of personal information: Name, Phone number, Email address, Residential address, Emergency contact details, Basic demographic information (e.g., age, gender), Health and fitness information (e.g., injuries, medical conditions, goals), and Payment details (e.g., credit/debit card or direct debit information).

2. How we collect personal information

We collect personal information directly from you when you complete forms on our website (<https://danspt.com.au/>), submit details via Facebook lead ads or social media, contact us by phone, email, or in person, sign up for our programs or classes, or use our booking system. We may also collect information automatically through cookies or analytics tools when you visit our website.

3. Why we collect personal information

We collect, hold, use and disclose your personal information for purposes including managing memberships and classes, providing fitness and personal training services, communicating with you, processing payments, conducting assessments, marketing and promotions (with your consent), and meeting our legal obligations.

4. Disclosure of personal information

We may share your personal information with trusted third parties who help us operate our business, including GymMaster (member management), email marketing platforms, and Facebook Ads. We take reasonable steps to ensure these providers handle your information in accordance with the Privacy Act. We do not share or transfer personal information outside Australia.

5. Sensitive information

We may collect health information to ensure safe and effective delivery of fitness services. This information is treated as sensitive information under the Privacy Act and will only be collected and used with your consent, and only for the purpose for which it was provided.

6. Data storage and security

We take reasonable steps to protect your personal information from misuse, loss, unauthorised access, modification, or disclosure. Your data is stored securely within Australia on

password-protected systems and trusted software platforms.

7. Access and correction

You may request access to, or correction of, your personal information at any time by contacting us using the details below.

8. Direct marketing

We may use your personal information to send you marketing communications, including updates and special offers. You can opt out of marketing communications at any time by clicking 'unsubscribe' in our emails or contacting us directly.

9. Complaints

If you believe your privacy has been breached or have a complaint about how we handle your personal information, please contact us. We will respond promptly and aim to resolve any issues within 30 days. If you are not satisfied, you can contact the Office of the Australian Information Commissioner (OAIC) at www.oaic.gov.au.
